# SIX POINTS PARK RULES OF USAGE

The following is an <u>extract</u> from the City of Toronto Municipal Code on use of city parks, found at <u>www.toronto.ca/legdocs/municode/1184\_608.pdf</u>. The extract contains only those rules that appear to be applicable to Six Points Park. For certainty, please see the above noted, full document. The ordering and numbering of the park usage rules presented here, <u>including those activities that require a city permit</u>, are provided for the convenience of residents of The Essex Condominiums.

Please note that The Essex Condominiums have no authority or responsibility to enforce any city park rules including these for Six Points Park.

While in Six Points Park, no person shall:

(1) Indulge in riotous, boisterous, violent, threatening, or illegal conduct or use profane or abusive language.

(2) Cast, throw or in any way propel any object in a manner that may or does endanger or cause injury or damage to a person or property.

(3) Create a nuisance by loitering, spying, accosting, frightening, annoying or otherwise disturbing other persons.

(4) Create a nuisance or in any way interfere with the use and enjoyment of the park by other persons.

- (5) Remove, disturb, relocate, damage or destroy protective fencing, lifesaving equipment, barriers and warning signage put in place for protection of the public.
- (6) Release any balloons filled with lighter-than-air gases in a park.

(7) <u>Without a permit</u>, be in possession of or use a firearm, air gun, cross bow, bow and arrow, axe, paint guns or offensive weapon of any kind.

(8) <u>Without a permit, ignite, discharge or set off firecrackers, rockets or other fireworks.</u>

- (9) Climb a building, structure or equipment, unless it is equipment designed for climbing.
- (10) Break, injure, deface, destroy, move or remove the whole or any part of a flower, plant material, fungus, tree or other vegetation or a building, structure, equipment or other property of the City.
- (11) <u>Without a permit, climb, move or remove the whole or any part of a tree, rock, boulder, rock face or remove soil, sand or wood.</u>
- (12) In any manner, disturb ground which is under repair, prepared for planting, has been newly seeded or sodded or is in an area <u>posted</u> to that effect.
- (13) Drive, park or walk in an area <u>posted</u> to prohibit the activity.
- (14) <u>Without a permit</u>, place, throw, cast or otherwise deposit snow.
- (15) <u>Without a permit, consume, serve or sell alcoholic beverages unless in designated areas, with the approval of the Liquor Licence Board of Ontario.</u>
- (16) Smoke tobacco or hold lighted tobacco within a nine-metre radius surrounding the edge of any playground safety surface or any playground equipment or within a nine-metre radius surrounding the edge of any wading pool basin or splash pad safety surface.
- (17) Without a permit, enter or gather in a park between the hours of 12:01 a.m. and 5:30 a.m.
- (18) <u>Without a permit</u>, light, build or stoke an open fire or bonfire.
- (19) <u>Without a permit</u>, use any portable barbeques where posted to allow the use.
- (20) <u>Without a permit</u>, hold a picnic, organized gathering or special event for more than 25 persons.

(21) Interfere with a picnic, organized gathering or special event authorized by permit.

(22) Move park furniture from an area to another area to accommodate their picnic, organized gathering or special event.

(23) <u>Without a permit</u>, operate loud speakers or amplifying equipment from any source in a park

(24) <u>Without a permit</u>, dwell, camp or lodge in a park.

(25) <u>Without a permit</u>, Install, attach or erect a temporary or permanent tent, structure or shelter at, in or to a park.

(26) <u>Without a permit</u>, arrange or engage in an organized sport or activity.

(27) Interfere with an organized sport or activity authorized by permit.

(28) <u>Without a permit</u>, utilize a designated area where it is <u>posted</u> to prohibit or restrict such use.

(29) Play or practise golf or strike a golf ball except on a golf course or in a designated area.

(30) <u>Without a permit</u>, operate powered models of aircraft, rockets, watercraft or vehicles..

(31) <u>Without a permit</u>, tether, launch or land a hot air balloon, hang glider, ultra light aircraft or similar conveyance in a park.

- (32) Operate or utilize roller blades, skate boards, linear skates or similar conveyances, where <u>posted</u> to prohibit or otherwise restrict the use of the conveyances.
- (33) Obstruct, inconvenience or endanger other users of the park while operating or utilizing roller blades, skateboards or similar conveyances.
- (34) Fly a kite with a line that is metallic or contains wire.
- (35) Fly a kite within 25 metres of any tree, building, light pole or hydro or other utility pole.
- (36) Fly a kite in parking lots, roadways or pathways.
- (37) Leave any part of the kite, including the string or other type of tethering material, that could cause damage to any person, property or wildlife, in the park.
- (38) Ride or operate or be in possession of a bicycle where posted to prohibit bicycles.
- (39) Obstruct, inconvenience or endanger other users of the park while riding or operating a bicycle.
- (40) Construct or assemble any ramps, jumps, pathways or obstacle courses.
- (41) Ride or operate a bicycle in a manner which results in damage to trails, vegetation, trees, fauna or other natural features.
- (42) As owner or person having control of a dog, excluding a working dog providing a service to the City, allow the dog to run at large, except in a <u>posted</u> designated off-leash area.

(43) As owner or person having control of a dog, excluding blind persons reliant upon a guide dog, and a working dog providing a service to the City, allow the dog to enter a prohibited area.

(44) Install or construct any type of dog control fence or barrier.

- (45) Use a stun gun or similar electronic or battery-operated device to harm or control the dog.
- (46) Allow a dog to enter a designated off-leash area if the dog is required to be equipped with a muzzle or secured by a leash under: (a) A notice issued under Chapter 349, Animals; or (b) The *Dog Owners' Liability Act* or an order issued under that Act.
- (47) As owner or person having control of a dog, ensure that it is on a leash or chain not exceeding 2.4 metres in length when not running at large in a <u>posted</u> designated off-leash area.
- (48) As owner or person having control of a dog, excluding disabled persons, pick up and immediately remove excrement left by the dog and dispose of it in a sanitary manner in a receptacle for litter or in some other suitable container.
- (49) As owner or person having control of a dog, not leave the dog unattended in a park or designated off-leash area.
- (50) As owner or person having control of a dog, keep the dog in sight and under care and control at all times.
- (51) As owner or person having control of a dog, repair any holes dug by the dog under their control.
- (52) As owner or person having control of a dog, ensure that female dogs in heat are on a leash or chain at all times and do not enter a designated off-leash area.
- (53) No person as owner or person having the control of an animal shall bring into or permit the animal to enter a park if it may or does constitute a danger to other persons or wildlife, or is reasonably likely to frighten other persons.

(54) <u>Without a permit, kill</u>, attempt to kill, maim, injure, trap or disturb wildlife.

(55) Without a permit, touch, injure or remove a nest or egg.

(56) Feed or attempt to feed or deposit food for consumption by wildlife.

(57) Release into a park pets, animals or domesticated species.

(58) Without a permit, remove, cut down, destroy or injure a tree or part of a tree located in a park.

(59) Mark, cut, break, peel, deface or bury the roots of a tree or any part of a tree located in a park.

(60) <u>Without a permit</u>, undertake or cause to undertake any activities that are contrary to the City's Tree Protection Policy and Specifications for Construction Near Trees and any other standards or conditions imposed or set out by the Commissioner for the protection of a tree located in a park.

(61) <u>Without a permit</u>, attach in any manner any object or thing to a tree or part of a tree located in a park.

(62) <u>Without a permit</u>, attach decorative lights to a tree located in a park and upon production of satisfactory evidence that all other requisite approvals have been obtained. The requests may be subject to conditions imposed by the Commissioner.
